Shooting incident USA

As I write this, news is circulating the world regarding the tragic shooting at the school in Sandy Hook elementary school in Newtown, Connecticut, USA. This type of event is particularly poignant to us who get so much pleasure from the sporting use of firearms. I am sure that I speak for all of us in sending our thoughts and condolences to our friends in America who are suffering because of this tragic incident.

There is little that can be done to prevent this type of incident but we as shooters must be on our guard as to who we invite into our sport and continuously monitor those around us. Our friends and families could be the next victims.

MLAIC Minutes 2012

You should have received the Minutes as an attachment with this document.

The minutes speak for themselves but I would like to make the following comments:

7.c. Flags. This item was deferred for resolution prior to the next championships. I suggest a rectangular flag with the MLAIC logo centrally located, the background to be similar to the current flag which I think is "ice blue" with a gold braid round the perimeter as per the current flag. Four flags will be required; one 2m for world championships and three 1.5m for LR W/C's and the two Zone events, the ratio of width to height to be based on the "Golden Section formula" (this is the most pleasing to the eye and should be known to the flag maker); I think standard A4 paper is a good example of this.

I have spoken to Merwe and Nancy; both have agreed to obtain quotes

Rules (Annex A):

- (1) 1.9. This section has been further modified and the relevant rule should be examined.
- (10) Certain proposals by Great Britain regarding Long Range were deferred for debate by those countries concerned but after very careful consideration I found that it was virtually impossible to reconcile the issue, the only solution was to place an exclusion at the heading of the General Rule; I found that this also applies to certain shotgun rules.
- (14) This proposal has been modified slightly, please see the relevant rule.

Report from the MLAIC Black Powder Committee

July 31st 2012

This committee was appointed by David Brigden in 2008. The following committee members contributed to this report:

Collection of information and reference materials has continued with special emphasis on the physical and chemical properties of BP (Black Powder). The survey of the storage regulations that was conducted a few years ago by this committee revealed, as expected, a great spread in national regulations, from almost no governmental interference to a virtual ban on storing BP in private homes. Additionally, several national BP organizations reported that their governmental regulatory agencies intended to or had recently revised their regulations related to storage of BP. There was valid concern from some MLAIC delegates that publishing the results from such a survey might lead to inappropriate reactions by local regulatory agencies.

The storage of BP in private homes is in many countries linked to the United Nations Recommendations on the Transport of Dangerous Goods, where BP is in the most restrictive class (1.1D). Most countries have fewer restrictions on the storage of smokeless powder (UN Class 1.3 and 1.4). A reasonable aim would therefore be to get BP in the same class as smokeless powder. These UN recommendations are concerned with the transport of dangerous goods TOGETHER with the packing used. This situation opens for a reclassification of BP by exploiting the physical and chemical properties of BP in conjunction with manipulation of either the size of the BP-canisters and/or the construction of the transport/storage device that the BP-canisters are placed in. A technical note by Ståle Helland and Barbara Grisdale-Helland with further details and supporting evidence is provided as an annex to this report.
